3. ICAO Technical Instructions for the Safe Transport of Dangerous Goods by Air and IATA DGR new provisions - <u>APPLICABLE IMMEDIATELY</u>

The International Civil Aviation Organization (ICAO) has published their third addendum to the 2015-2016 Edition of the Technical Instructions: See this web link http://www.icao.int/safety/dangerousgoods/pages/technical-instructions.aspx.

The document dated 15 January 2016 introduces some new provisions that were deemed as safety-critical and are applicable immediately. The changes include the assignment of special provision A210 (forbidden for carriage by air) against catecholborane and 1,3,2-benzodioxaborole, further changes to the restrictions on the carriage of lithium batteries, and a clarification on lithium batteries in overpacks.

The International Air Transport Association (IATA) has posted on 16 January an addendum to their Dangerous Goods Regulations 57th Edition effective for the year 2016. 4. Mali and Jamaica, two additional ratifications for the Trade Facilitation Agreement

Mali has ratified the new Trade Facilitation Agreement (TFA), becoming the 10th African nation to do so. Mali has also accepted an amendment to the TRIPS Agreement aimed at facilitating access to essential medicines in poor countries that was adopted in 2005.

Jamaican Prime Minister Portia Simpson Miller has confirmed her country's ratification of the TFA during a meeting with WTO Director-General Roberto Azevêdo in Kingston on 19 January. To read more about

The poverty rate is systematically higher and more persistent in LDCs than in other developing countries; and within LDCs it is twice as high in rural areas as in towns and cities, and rural poverty is more extreme than urban poverty. 11. Platform released for UN High Level Political Forum (HLPF), 11 - 20 July 2016, New York

The HLPF is the central UN platform for the follow-up and review of the <u>2030 Agenda for Sustainable</u> <u>Development</u> adopted at the United Nations Sustainable Development Summit on 25 September 2015. HLPF 2016 will be the first HLPF after the adoption of the 2030 Agenda for Sustainable Development.

12. ACE (Automated Commercial Environment) Transition for PGA (Participating Government Agencies) Requirements Mandatory in July, 2016

Effective February 28, 2016, all cargo release and entry summary transactions must be filed in ACE. At this time, FDA, NHTSA (DOT), and APHIS Lacey Act will also be mandatory in ACE via the PGA message set.

Additional PGA's will also be required to be filed in ACE in July, 2016 via the PGA message set. Until that time, filers have the following options to file those PGA documents when required for cargo release processing. 13. The Asian Development Bank (ADB) - What Does the Paris Climate Deal Mean for Asia and the Pacific?

At the 2015 Paris Climate Conference in December, 195 nations agreed to cut greenhouse gas emissions to limit the rise in the global average temperature to below 2 degrees compared to preindustrial levels. The agreement also set a goal of mobilizing \$100 billion per year starting 2020.

How can the agreement make a genuine difference in Asia and the Pacific given the commitment of large economies in the region to continue with a fossil fuel-based growth strategy? 14. SESAR Deployment Manager and EIB join forces in support of Single European Sky Initiative

Vice-President of the European Investment Bank (EIB) Pim van Ballekom and Managing Director of the SESAR Deployment Manager (SDM) Massimo Garbini signed a Memorandum of Understanding (MoU) to reinforce and expand cooperation between the two organisations.

The SDM is tasked by the European Commission with developing and implementing the technology deployment phase of the Single European Sky Initiative, meant to defragment the EU's airspace so as to increase capacity, improve safety, lower environmental impact and reduce costs for airspace users. 15. Record €12.7 billion investment in transport now ready to deliver better mobility, new jobs and growth

Announced in June 2015, the Commission's investment plan for the transport sector is now fully operational, after the Innovation and Networks Executive Agency (INEA) finalised the signature of all grant agreements for projects selected under the 2014 Connecting Europe Facility (CEF).

A total of €12.7 billion of EU investment will support 263 transport projects contributing to faster, safer and greener mobility in the EU. This will also play a major role in bridging the investment gap in Europe, which is one of the Commission's top priorities. It is worth noting that CLECAT and FIATA had been advocating for such development in the EU investments for years.
