The 137 economies represent 96% of the world population and 99% of world GDP. Among the top 10 economies on the Index, six are European, three are from the Asia-Pacific region and one is from North America.

#### 10. EU, Mercosur Prepare to Revamp Trade Talks in May

The EU and Mercosur are set to ramp up their long-struggling trade talks, with officials from both sides confirming plans to exchange market access offers in goods and services during the second week of May.

The news, <u>confirmed</u> in early April by EU Trade Commissioner Cecilia Malmström and Uruguayan Foreign Minister Rodolfo Nin Novoa, has fuelled a renewal of interest - and controversy - over the talks, which were first launched in 1999.

## 11. EU Commission adopts the new Work Programme for the Union Customs Code (UCC)

With the adoption of the Commission implementing decision of 11 April 2016, the Commission repeals and replaces the outdated Work Programme of 29 April 2014 (Decision n° 2014/255/EU) by a brand new decision taking into account the latest legal, transitional and operational developments for the UCC.

The Work Programme aims to govern, plan and manage the electronic environment underpinning the UCC in a proper and staged manner, as from the date of application of the Code, i.e. 1 May 2016, till its full implementation, i.e. 31 December 2020.

The Work Programme for the Union Customs Code is available in the Official Journal L99 of 15/04/2016.

#### 12. OECD - Illicit Trade

The OECD report assesses the magnitude, flows and drivers of illicit trade and the illegal economy including: narcotics, human trafficking, wildlife, sports betting, counterfeit medicines, alcohol and tobacco. The negative socio-economic impacts that these markets have in consumer countries are as worrisome as the governance gaps that are exploited in source countries.

## 13. OECD - Trade in Counterfeit and Pirated Goods

Counterfeit and pirated products come from many economies, with some producing market larger than others. These illegal products are frequently found in a range of industries, from luxury items (e.g. fashion apparel or deluxe watches), via intermediary products (such as machines, spare parts or chemicals) to consumer goods that have an impact on personal health and safety (such as

pharmaceuticals, food and drink, medical equipment, or toys). Counterfeit trade poses threats to logistics enterprises which should be apprised of existing risks.

#### 22. UNCTAD - Data Protection Framework

UNCTAD maintains that the Data Protections Framework must be compatible with International data flows for developing countries to benefit from the global digital economy.

National and regional legal frameworks that protect data in the ever-expanding digital economy are often outdated, incompatible or missing, UNCTAD has found.

In a new report, <u>Data Protection Regulations and International Data Flows: Implications for Trade and Development</u>, UNCTAD says that <u>coherent and compatible data protection regimes</u> will be ever-more important in the face of new technologies such as cloud computing, big data, and the Internet of Things. More dialogue between all stakeholders is needed to achieve adequate protection, the report urges.
