#### 4. DG Azevêdo welcomes efforts to boost opportunities for small businesses

Director-General Roberto Azevêdo attended a workshop today (21 June) on micro, small and medium enterprises (MSMEs), focused on enhancing their participation in international trade. The event was organised by the permanent missions of the Philippines, Lao PDR, Malaysia, Brunei Darussalam, Singapore and Thailand, supported by the International Trade Centre (ITC).

The discussion focused on the specific barriers that MSMEs face in the global trading system and what steps could be taken to lower those barriers.

#### 5. Liberia to become 163rd WTO member

Liberia has notified the WTO that its Parliament has ratified its Protocol of Accession, clearing the final pathway to its WTO membership. According to WTO rules, Liberia will become a WTO member on 14th of July, 30 days after its instrument of acceptance was deposited at the WTO.

#### 6. Madagascar joins list of WTO members ratifying the Trade Facilitation Agreement

Madagascar has joined the growing majority of WTO members that have ratified the WTO's Trade Facilitation Agreement (TFA). Mr Solofo Andrianjatovo Razafitrimo, Madagascar's Minister-Counsellor and Chargé d'Affaires in Geneva, presented his country's instrument of ratification to WTO Director-General Roberto Azevêdo on 20th of June.

## 7. SPECA countries using the UN Trade Facilitation Implementation Guide

Senior trade and Customs officials from Azerbaijan, Kyrgyzstan, Tajikistan, and Turkmenistan (countries participating in the UN Special Programme for the Economies of Central Asia known as SPECA) received practical advice on the implementation of trade facilitation at a training workshop co-organized by UNECE and the Organization for Security and Co-operation in Europe (OSCE) in Dushanbe. The interactive workshop aimed to give participants awareness of the tools contained in the UN Trade Facilitation Implementation Guide and how to use them.

#### 8. WTO members share experiences on National Trade Facilitation Committees

On June 8th Experts from more than 20 countries and 5 international organisations gave presentations to representatives from more than 150 countries participating in a workshop on National Trade Facilitation Committees, in the framework of WTO's Trade Facilitation Agreement (TFA). Guidelines have been developed by several international organisations and other donors to address states' difficulty in structuring national committees. A survey conducted by the WTO Secretariat confirmed that considerable work is being done by Members in this area. The preliminary results of this survey are available <u>HERE</u>

## 9. African countries and EU sign Economic Partnership Agreement

On 10th of June, six countries from the Southern African Development Community (SADC) - specifically, Botswana, Lesotho, Mozambique, Namibia, South Africa, and Swaziland - signed an Economic Partnership Agreement (EPA) with the EU in Kasane, Botswana. Those SADC countries will now have to ratify the regional agreement before it can enter into force.

The trade deal secures access to the EU market without any duties or quotas for all members of the SADC EPA group, removing customs duties on 98.7 percent of imports from South Africa and eliminating them entirely for the other five countries.

## 10. African countries hold second CFTA Negotiating Forum

Representatives from the African Union's (AU) member states held the second session of the Continental Free Trade Area Negotiating Forum (CFTA-NF), continuing their work aimed at laying the foundation for the upcoming substantive negotiations. If successfully concluded, the CFTA would constitute the largest FTA in the world, covering 54 member states.

## 12. EU Single European Rail Area closer to completion as new provisions enter into force

The <u>technical provisions</u> of the Fourth Railway Package are entering into force. These are a series of measures adopted by the European Parliament and the 28 Member States to make European railways more innovative and competitive. They will in particular promote common EU rail standards and approvals with a view to establishing a deeper internal market.

Argentina is now an official observer to the Pacific Alliance, the South American bloc that includes Chile, Colombia, Mexico, and Peru as full members. While observer countries have speaking rights, they cannot vote on Pacific Alliance decisions, and are allowed to attend the group's meetings so long as they have been invited.

## 17. EU Aviation Safety, EU air safety list registers Iranian and African progress

The European Commission updated the EU Air Safety List, the list of airlines that do not meet international safety standards, and are therefore subject to an operating ban or operational restrictions within the European Union. This complies with the EU Aviation Strategy adopted in December 2015. The EU Air Safety List, one of the Union's main instruments in aviation policy, register important improvements.
