# 2. UN General Assembly - Ghana and New Zealand highlight Importance of Trade

What Africa needs is not development assistance from developed countries but "a fair chance" to trade with the rest of the world, the President of Ghana told the United Nations General Assembly. He said that raising intra-African trade alone of 15 per cent will create better opportunities for Africa's youth.

In addition, the Prime Minister of New Zealand called on the World Trade Organization (WTO) "to do more to set global trade rules". Underlining that sustainable economic development, a key driver of global growth, prosperity and stability, requires a fair, rules-based trading system, more open trade and the removal of trade barriers

### 4. WCO and UNCTAD jointly for Ghana's National Trade Facilitation Committee

From 29th of August to 1st of September, the WCO and UNCTAD carried out a joint capacity-building workshop benefiting 37 representatives of the Ghana's NTFC, including 18 women. The present mission is the logical follow-up of the previous workshops held in Ghana held in January and May 2016. The workshop focused on concepts related to the global supply chain, trade facilitation programme, indicators, donor engagement as well as the Revised Kyoto Convention and its importance in relation to the implementation of the WTO TFA.

### 5. 1st WCO Working Group on e-Commerce gets down to Business

More than 175 delegates joined FIATA in attending the 1st meeting of the WCO Working Group on eCommerce. New revenue collection models which would allow all duties and taxes to be collected more efficiently were discussed, also touching on the de-minimis threshold for duties and taxes, as powerfully advocated by the numerous express industry presence.

The WCO presented the preliminary results on the survey it carried out to collect current practices and ongoing and/or future initiatives on cross-border low-value e-commerce. The survey highlights the lack of harmonization in the low-value shipment process, the need for digitalisation of processes, the need for innovative solutions to be developed in order to capture better information from importers and e-commerce intermediaries in particular, to enable better risk assessment.

#### 6. Bangladesh ratifies Trade Facilitation Agreement

Bangladesh has ratified the Trade Facilitation Agreement, becoming the 94th member of the WTO and 12th least developed country (LDC) to do so. Bangladeshi WTO ambassador Shameem Ahsan submitted his country's instrument of acceptance to WTO Director-General Roberto Azevêdo on 27th of September.

For the first time in WTO history, the requirement to implement the Agreement was directly linked to the capacity of the country to do so. Stressing that Africa is not risky for investment in transboundary infrastructure, ECA's Executive Secretary, Carlos Lopes, said on Monday in New York that the quest for regional integration in Africa made trade and transboundary infrastructure critical and called on sovereign wealth funds to support African development by investing in sustainable infrastructure which, he said, is the growth story of the future.

Launching ECA and NEPAD Agency's publication, "16: Infrastructure projects for African integration" at the NASDAQ Stock Exchange, Lopes said the 16 infrastructure projects profiled in the publication were selected by African heads of state based on the priorities of the continent and their potential impact for regional integration.

### 11. AfDB approves Millionaire Trade Facilitation Loan

The Board of Directors of the African Development Bank (AfDB) approved in Abidjan on September 21st, 2016, a US\$ 310 million trade finance loan for Ecobank Transnational Incorporated, parent company of the Ecobank Group. Through this facility the AfDB will provide critical trade finance funding to support economies in which Ecobank is present.

The project will help address critical market demand for trade finance and dollar liquidity by supporting vital economic sectors such as agri-business, chemicals, construction, engineering, food processing, manufacturing and non-traditional exports.

The Asian Development Bank (ADB) will provide \$1.5 billion to Bangladesh to build a dual-gauge railway line that will bring key trade and tourism to the southernmost parts of Bangladesh. The new railway, part of the Trans-Asia Railway network, will also improve access to Myanmar and beyond.

The Trans-Asia Railway - an initiative led by United Nations Economic and Social Commission for Asia and the Pacific - aims to provide seamless rail links between Asia and Europe to better connect people and markets.

### 14. Multiple Partnerships Agreements realised at ICAO 2016 World Aviation Forum

The second ICAO World Aviation Forum concluded on numerous positive notes at the UN aviation agency's Montréal Headquarters, where FIATA was in the attendance. The high-level participants reaffirmed the critical importance of safe, secure and efficient air transport operations to the sustainable

socio-economic development of cities, States, and regions, while exploring new means of creating momentum for greater cooperation to optimise these benefits.

They also agreed to work together to significantly boost the current 4.2% of annual Official Development Assistance (ODA) financing presently earmarked for air transport development globally.

In addition to the expected agreement on the aviation MBM (see below), governments at the 39th Assembly are also expected to endorse new amendments to ICAO's global strategic plans for aviation safety and air navigation efficiency, as well as recommend that ICAO now develop similar global plans for aviation security and facilitation and air transport economic development

#### 15. Agreement on International Aviation Emissions expected at 39th ICAO Assembly

One of the most ambitious events of its kind in ICAO's over seven decades of managing global air transport cooperation and progress, the 39th Assembly, which runs through 7th of October, is expected to adopt the first ever global market-based measure (MBM) by any industry sector covering CO2 emissions from international activity.

"Under ICAO's new Global Aviation Security Plan, states, regions, industry and other stakeholders will be unified through a strategic framework that offers clarity on priorities for aviation security enhancement," Dr Liu remarked at UN Security Council, noting ICAO's invaluable support in achieving aviation security objectives, and in effectively contributing to the UN Security Council resolutions as well as the UN Global Counter-terrorism Strategy.

On that same day, the Security Council unanimously adopted Res 2309 on countering terrorist threats to civil aviation.

Some of the key expected outcomes are:

- UNECE Recommendation on Public-Private Partnerships (PPP) in Trade Facilitation;
- Launching of a new UN/CEFACT project on core operational aspects of Single Windows;
- Final draft of UN/CEFACT standard for traceability of agricultural products, including animal and plant fibres;
- Completion of the project that produced the **Verified Gross Mass (VERMAS) message** that allows the transmission of the weight and related details of a packed container.

### 18. UN/CEFACT opening of the Public Review for Single Window Interoperability (SWI)

UN/CEFACT announced the opening of the Public Review period for Recommendation 36 - Single Window Interoperability (SWI). The new recommendation covers the mechanism required for the interconnectivity of two or more Single Window facilities. The recommendation also addresses the need for cross-border trade information exchange which requires the exchange of data/information beyond the National Single Window, i.e. across their border.

The group will officially begin during the <u>28th UN/CEFACT Forum in Bangkok</u> with a <u>Mini Conference</u> on Wednesday 28 September.

### 20. UNCTAD - Technology opens New Opportunity: prepare for Disruption

With global growth now in its sixth flat year, many political leaders - including those that gathered for the G20 Summit in Hangzhou earlier this month - are looking to technology to create jobs and other economic opportunities.

Opportunities include the opening of new markets. The market for the internet of things, for example, those objects and devices used in daily life, is expected to rise to \$1.7 trillion in 2020 and to as much as \$11.1 trillion by 2025, according to the UNCTAD foresight report. In 2015, it was valued at \$655.8 billion.

## 23. ICAO and the EU renew Environmental Partnership

On the eve of the 39th Assembly, the International Civil Aviation Organization (ICAO) and the European Union have signed a declaration of intent renewing their partnership to address climate change. The cooperation was initiated in 2013 and supported a 6.5-million-euro capacity-building and assistance project implemented in 14 selected States in Africa and in the Caribbean. Each state has successfully submitted an action plan on CO2 emissions reduction activities to ICAO, with a total of 218 CO2 mitigation measures having been identified and now commencing implementation.

### 25. OECD - Carbon Pricing Efforts falling short, Collective Action make for Progress

Current carbon prices are falling short of the levels needed to reduce greenhouse gas emissions driving climate change, but even moderate price increases could have a significant impact, according to new OECD research.

Effective Carbon Rates: Pricing CO2 through taxes and emissions trading systems presents new data on effective carbon rates on CO2-emissions for energy use across 6 economic sectors in 41 countries (34 OECD member countries and 7 partner economies: Argentina, Brazil, China, India, Indonesia, Russia and South Africa) find a major gap between current carbon pricing policies and what is needed, EUR 30 per tonne of CO2.
