#### 3. UN General Assembly Grants Observer Status to International Chamber of Commerce

In an unprecedented move, the United Nations (UN) General Assembly granted Observer Status to the International Chamber of Commerce (ICC), the world's largest business organisation representing more than six million members in over 100 countries.

The new role for ICC means that business will have direct voice in the UN system for the first time. FIATA works closely with the ICC through the Global Business Alliance and Global Alliance on Trade Facilitation and congratulates the ICC on this achievement.

# 4. SAVE-THE-DATE: ICAO 2nd Meeting on Sustainable Air Transport in Africa

The meeting will be held in partnership with the Ghana Civil Aviation Authority (GCAA) in Accra, Ghana, between 28th and 31st March 2017. This meeting will focus on the implementation of the Antananarivo Declaration, adopted at the meeting in Madagascar in March 2015 to support the development of air transport in the Continent. The meeting will build on discussions for implementation of the Yamoussoukro and Lomé Declarations to liberalise air transport across Africa.

#### 5. WTO - Canada Ratifies the Trade Facilitation Agreement

Canada has ratified the Trade Facilitation Agreement (TFA), making it the 103rd WTO member to do so. Only seven more ratifications from members are needed to bring the TFA into force. According to a 2015 study carried out by WTO economists, full implementation of the TFA would reduce members' trade costs by an average of 14.3 per cent, with developing countries having the most to gain.

#### 6. WTO - EU donates EUR 1 million to help developing countries participate in trade talks

The donation will finance trade-related technical assistance and capacity building activities for officials in Geneva and elsewhere to help them better understand and implement WTO agreements and to enhance their negotiating skills. Since the creation of the Fund in 2001, more than 2,400 training and capacity building activities have been organized.

#### 7. UNCTAD launches its 2016 Handbook of Statistics

With this Handbook, UNCTAD offers trade data that are largely based on final official figures, and which provide a greater level of detail than any other dataset on trade. By supporting policy analysis, this resource will help policy makers to implement better and more effective policies.

According to the Handbook the value of global merchandise trade fell 13% from \$19 trillion in 2014 to \$16.6 trillion in 2015, making 2015 only the second year since 2000 in which merchandise trade declined.

#### 8. UNCTAD - eTrade for All Initiative gathers pace, sets platform launch for April

Policy makers in developing countries will be able to access cutting edge technical and financial assistance on eCommerce, when the eTrade for All launches its new web platform in April, an UNCTAD official said. ## 9. ICAO Launches Unmanned Aircraft Systems (UAS) Toolkit

Given that UAS, informally referred to as "drones," can be mistakenly and often illegally operated by less-informed pilots around airports and other areas of controlled or sensitive airspace, ICAO has been

taking steps to help minimise their risks. Its new UAS Toolkit is much more than a starting point for learning the basics of their safe operation.

UAS today can be flown in a variety of configurations, and outfitted with a wide range of payloads and sensors to support their increasing humanitarian and emergency operations roles. They are also being used to monitor infrastructure and crops and for wide-ranging geological, geographical and climate-related research and development. FIATA recently had a drone operating logistics company participate in our Dublin World Congress to showcase advances in drone technology to perform the last mile delivery.

#### 13. UNFCCC - Clarifying Long-term Emission Reduction Strategies

The secretariat of the UN Framework Convention on Climate Change (UNFCCC) hosted a webinar on submitted long-term emission reduction strategies on Thursday 8th of December. During the webinar, Germany and the United States presented their long-term low emission development strategies, which were submitted to the UNFCCC secretariat during the UN Climate Change Conference (COP22) in Marrakech in November. To meet the central goal of the Paris Climate Change Agreement, which is to limit global warming to well below 2°C and as close to 1.5°C as possible, as well as to achieve climate neutrality in the second half of this century, long-term climate planning is required.

#### 14. With new Pledges and Project, Climatescope Take Clean Energy on

Key group of emerging nations builds 18% more renewable capacity than wealthier countries and four in five have now set national clean energy targets. This marks the third year Climatescope has been conducted globally and reflects activity in 2015, a year that culminated with the signing of the Paris Climate Agreement at UN-sponsored talks in December. In the run-up to those negotiations, three quarters of the Climatescope nations submitted or reiterated pledges to cut their future CO2 emissions. An even higher number are now on record with promises to achieve certain clean energy consumption goals in coming years.
