4. WCO Private Sector Consultative Group Meets to Discuss Customs and Trade Issues

The WCO Private Sector Consultative Group (PSCG) met for the 40th time at WCO headquarters on 27 and 28 February 2017. The meeting was attended by representatives from 18 of the 21 PSCG members from various industries.

The Group provided comments and proposals from an industry perspective on the WCO Strategic Plan 2016-2017 and the draft WCO Environmental Scan. Moreover, the Group was updated on the issue of eCommerce by the Co-Chair of the WCO E-Commerce Working Group, Marianne Rowden from AAEI, and by Ana Hinojosa, WCO Director of Compliance and Facilitation.

5. WCO TFA Working Group and Capacity Building Committee Joint Session

The World Customs Organisation Trade Facilitation Agreement Working Group (TFAWG) successfully concluded the second day of its 7th Meeting. The second day consisted of a Joint Session with the 8th Meeting of the Capacity Building Committee (CBC). Discussions focused on the implementation of the WTO Trade Facilitation Agreement (TFA) that entered into force on 22 February 2017.

The Joint Session of TFAWG and CBC discussed the successes of the WCO Mercator Programme, a dedicated Capacity Building Programme consisting of WCO Instruments and Tools such as the Revised Kyoto Convention (RKC) and the WCO Time Release Study (TRS) to support Members in the harmonised implementation of the TFA.

13. IATA Cargo Handling Manual to Promote Standardisation of Cargo Handling

Whilst taking account of the established rebound of air cargo, IATA announced during the World Cargo Symposium in Abu Dhabi, the launch of the <u>IATA Cargo Handling Manual</u> (ICHM) to help airlines and cargo handlers work together more effectively while improving safety and efficiency in air cargo operations. The ICHM is a set of standards covering the operational activities of all stakeholders in the cargo handling supply chain. It was developed in consultation with Air Carriers and Cargo Handlers, based on industry best-practices, the <u>Cargo-iQ Master Operating Plan</u> (MOP) and international regulations and standards.
